<u>Sunday, 7th of October</u>	Departure of participants.
Participation	This World Cup is open for all EJU / IJF Member Federations: Maximum 4 competitors per weight category for every federation. The competitors must be of the same nationality as the national federation, which enters them.
Age	Minimum 15 years of age (born in 1997 or before).
Competition Mode	The competition will be carried out according to the rules and sporting codes of the IJF and EJU. Competition system: An elimination (KO) system with the quarterfinal (last 8) repechage.
Duration of contests	5 minutes and the Golden Score 3 minutes.
Weigh-in	Athletes must present their EJU accreditation and passport at the official weigh-in. For time and place of the official weigh-in see the Program.
Refereeing	Each federation may enter 1 referee The organizing federation a maximum of 4 referees . Referees must be holding the IJF license A or B and with a valid classification A or B. A referee meeting will be held on <u>Friday 5th of October 2012 at 19:00hrs</u> at the Hotel PLANETA. The attendance to the Referee meeting is strictly compulsory. The referees should be dressed formally for this meeting.
Draw	Seeding of the top 8 among the entered competitors according to the IJF World Ranking List. The rest s of the draw – separation by nations. The draw will take place on <u>Friday at 20:00hrs</u> in Hotel PLANETA. Each delegation must be represented at the draw, maximum two officials. Dress code: jacket suit with tie.
Jumas	According to EJU rules Jumas inscription is obligatory. Participants must be registered in Jumas, otherwise they will face a late entry fee of € 30 per participant. The deadline is <u>Monday 1st of October 2012</u> (<i>of the week of the Tournament</i>). Participants without a valid EJU Jumas membership have to pay a € 30 penalty per participant. Jumas membership must then be

Entry fee	An entry fee of 10 € per athlete must be paid to the EJU during accreditation.
Coaching	All coaches must fully adhere to the Code of Conduct for Judo Coaches. Dress Code: - Draw: jacket suit and tie - Elimination rounds: national track suit with trousers reaching down to shoes or Jacket suit with Tie. For the final block program (TV time): jacket suit with tie.
Judogi	The competitions will be held in white and blue judogi. Judogi control according to IJF Sokuteiki Rule. Only Judogi from IJF suppliers will be allowed. Judogi markings must be in accordance with the EJU regulations. Detailed information is available from http://www.eju.net/statutes
Back Numbers	All competitors must have the official EJU / IJF Back Number (ordered from www.mybacknumber.com). The sponsor part will be provided by the organisers during accreditation. If the Judogi of the athlete does not comply with all the specifications of the EJU and the IJF, including the Back Number, the athlete will be disqualified from the tournament. Advertising	The space on the shoulder stripes can be only used by the EJU Suppliers. Further information is available from http://www.eju.net/statutes Advertising on the arms (10cm x 10cm on both right and left side) can be used by federations and their Judoka as usual for their own benefit.

Please, send in due time the list of delegation members with their valid passport details (number, dates of issue and expiry), date of birth and intended period of stay (arrival/departure dates) to the tournament organizer. Please, specify where your delegation is planning to obtain visas – in your country, or at the ART.</p> <p>Important information: The cost of Entry Visa to Belarus at Minsk Airport Consular Department for the countries having not the Consular Department of Belarus: Individual – 90 EUR. For the countries who have Belarusian Embassy- the cost of Entry Visa is 180 EUR. (Payment in USD and Euros).</p>
